The pre-contract is drawn up by the notary where both lawyers ensure both parties involved are protected and agree to this 20 process in order to proceed.

Once the buver's lawver has the completed property file, it is then presented to the Notary who will check all before proceeding to Final Contract.

buver cannot be present on the date of the final contract. a Power of Attorney would need to be arranged prior to this date.

The updated survey diagram (Topografiko) is presented to the buyer's lawyer and any other title deeds/documents necessary for the specific property.

Once the notary checks and agrees to all the information presented in the completed property file a decision is made 24 to complete the Final Contract.

Sign and exchange contracts is completed by both parties and money is received.



The agreed agent fees are paid on the day the final contract is exchanged via bank transfer.



Providing a professional service with exceptional communication



There is a new law which will be implemented in two years' time which states that there is no 'zone' allocation for a property. Your property will clearly state if it is in either 'town', or 'out of town'

If you have a property which is 'out of town' and less then 4000m2, you are not permitted to build/develop. However, always check with the engineer, as there are exceptions.

All monies owed on the property and taxes would need to be settled by the seller before sale of property goes through. This can be done by your accountant.

It is advised to have a lawyer who will be able to assist you with any outstanding paperwork you may require in order to complete the selling process. This is the responsibility of the seller.

Every property sale is subject to a 2% agent fee, 3% notary fee, 1% lawyer fee, as well as country property taxes such as VAT.

It is possible to complete a sale if you are not present in Greece in person. You can appoint a Power of Attorney to sign on your behalf.

MV Properties advises all properties to have the necessary paperwork in order, before we advertise.
